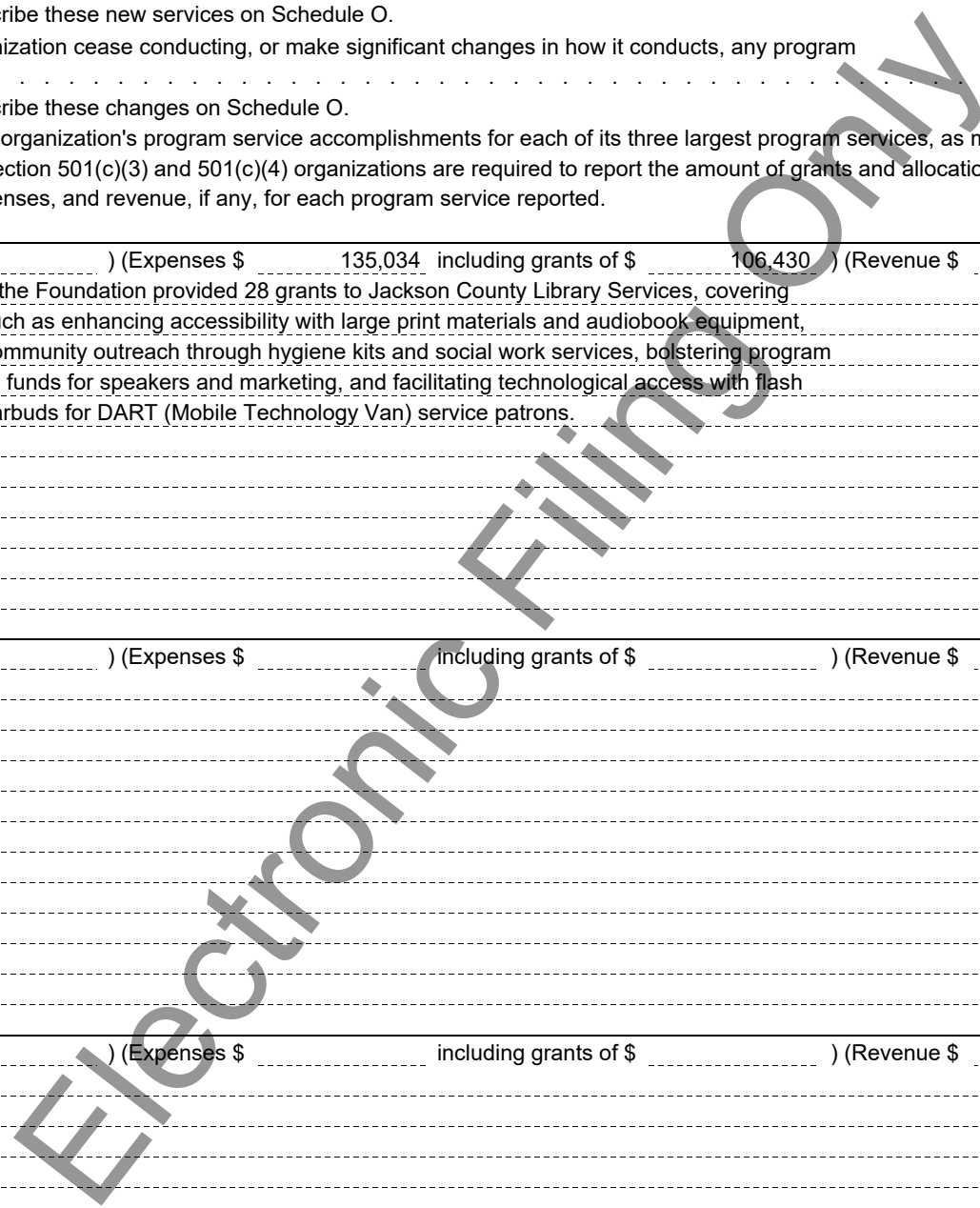

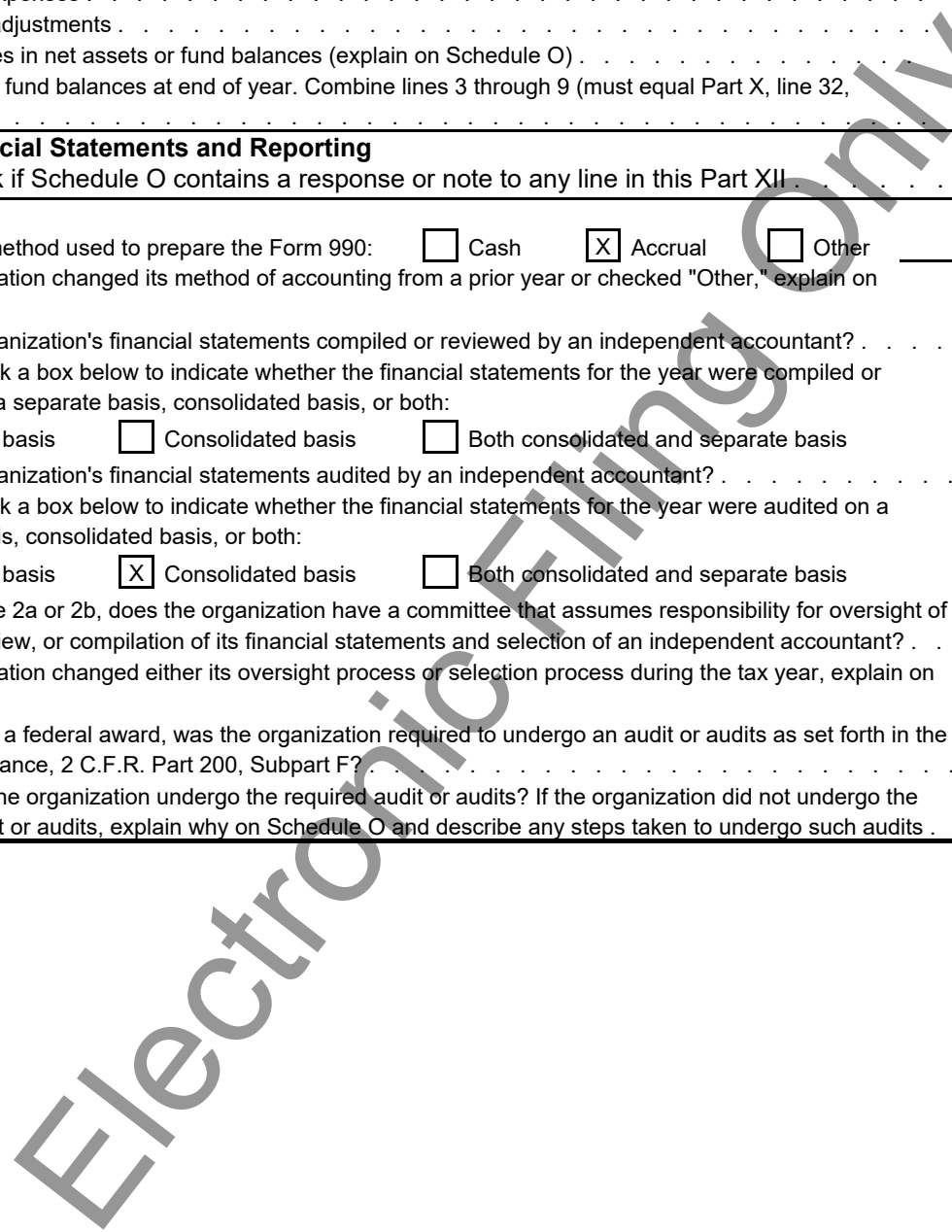

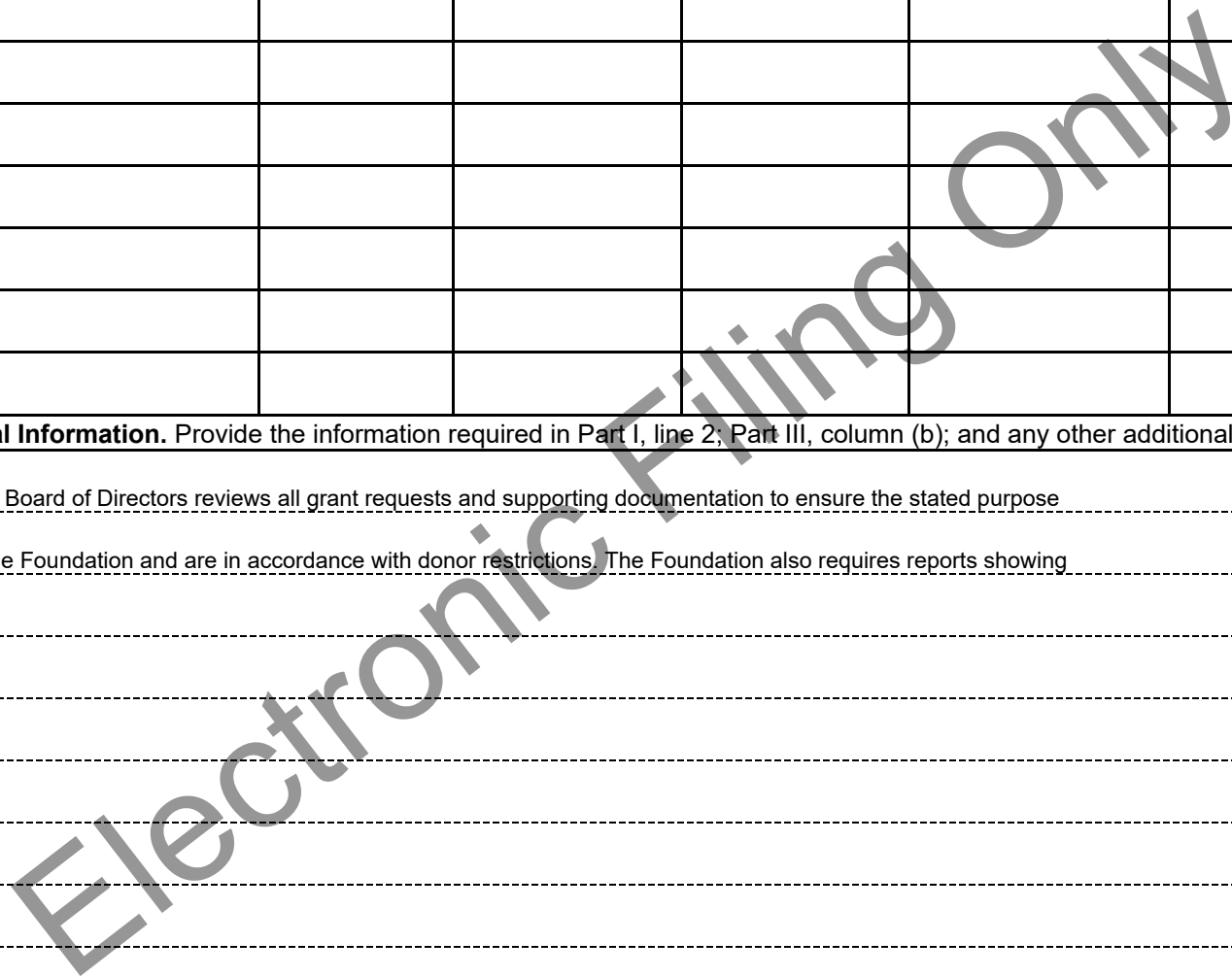

take action related to the Foundation's Executive Director without consulting the Foundation's
