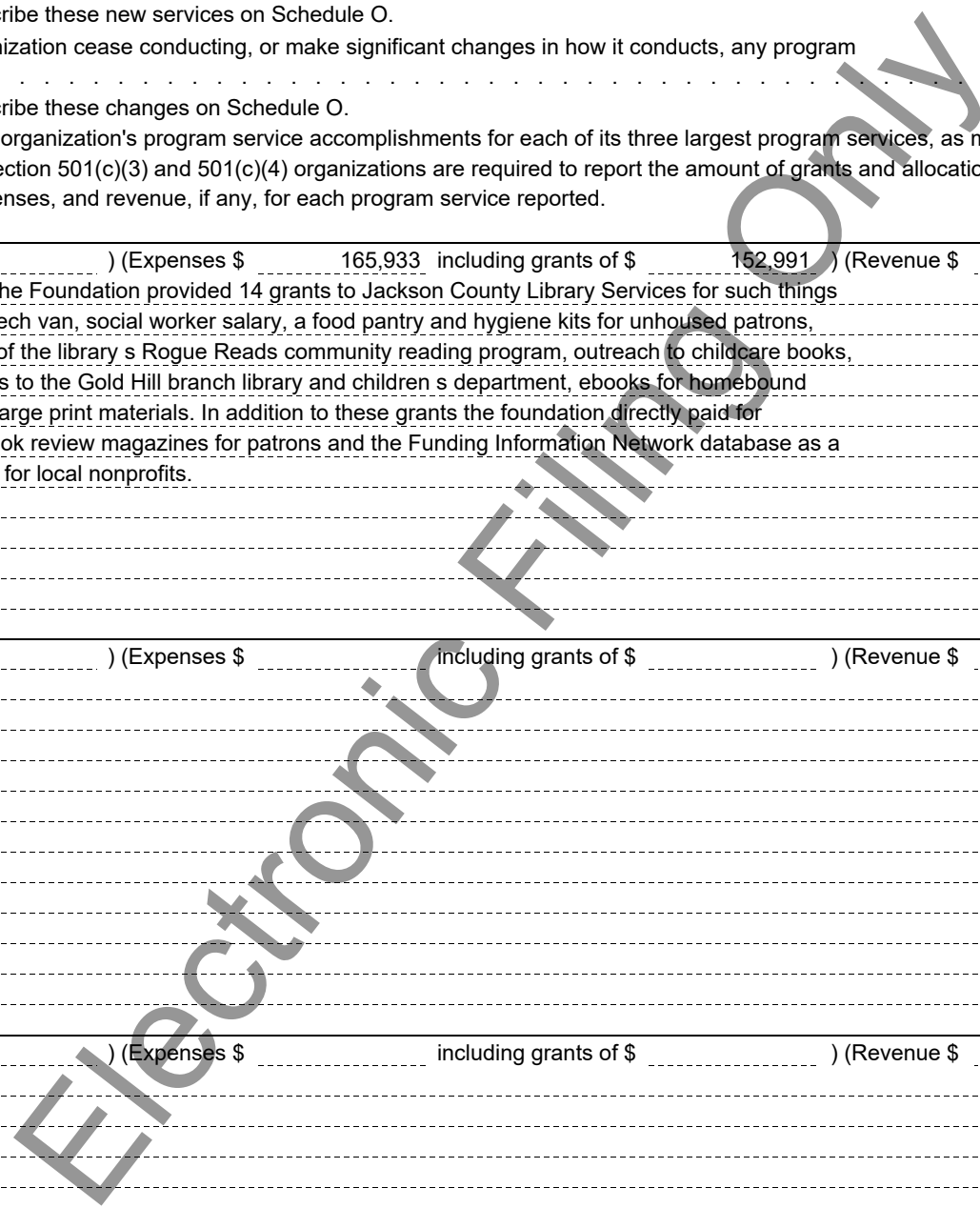

In addition to these grants the foundation directly paid for Bookpage book review magazines for patrons and the Funding Information Network database as a resource tool for local nonprofits.

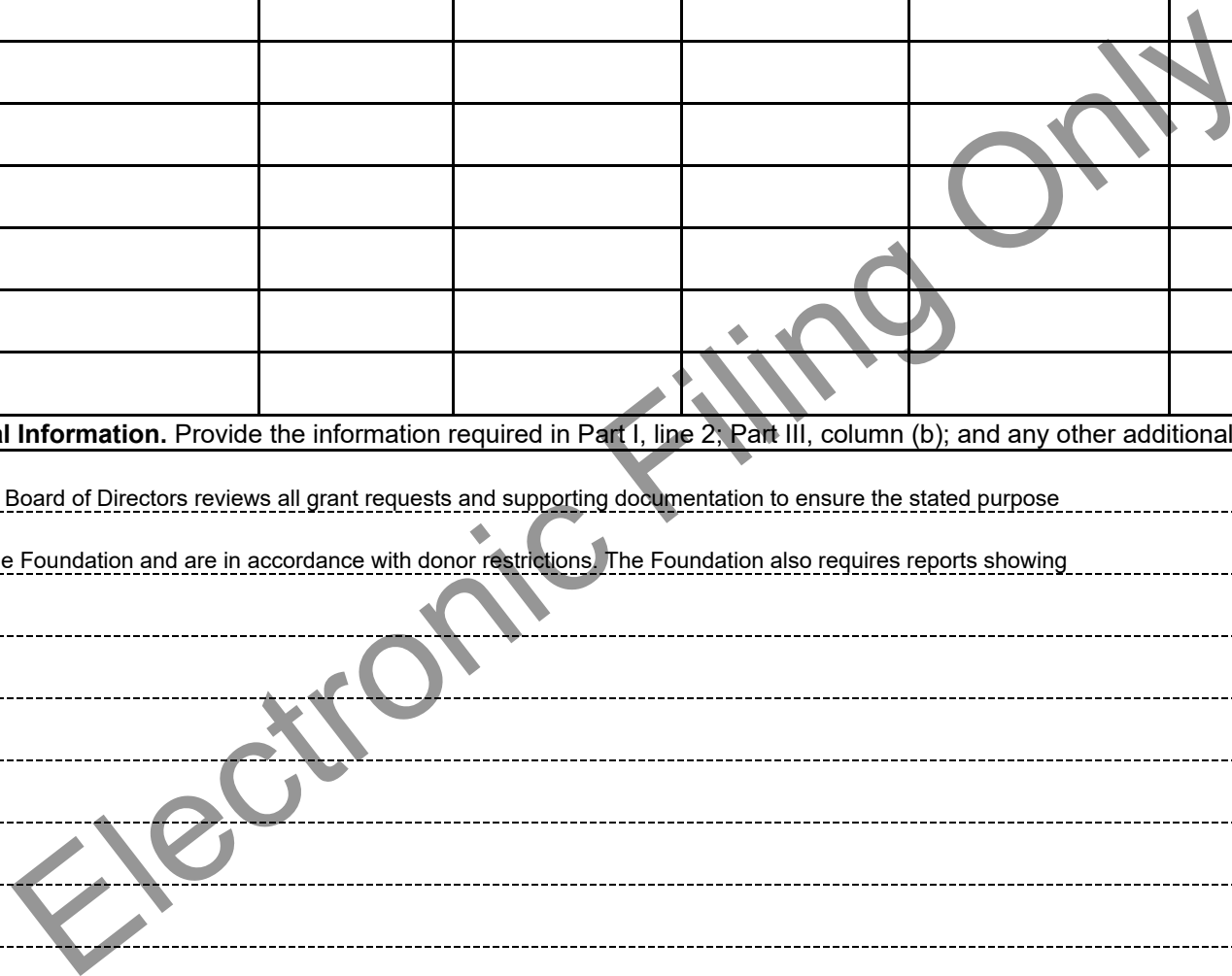
